



AFFILIATE AGREEMENT

By signing up to the Mobile IT & Training Solutions LLC Affiliate Program you are agreeing to the following terms and conditions.

Links & Promotion

Upon acceptance of these terms and conditions you will be supplied with a customized dropdown underneath the “Affiliate/Referral” section of the registration form on www.mitntraining.com. You will also receive an Affiliate page to monitor your sign ups and pay out activity. To be eligible to earn an affiliate fee, the user must select your name/organization/business name as a referral and/or Affiliate during their sign up.

Fees & Payment

The affiliate fee is 10% of our revenue from new registered students that you refer. The affiliate fee will be credited to your Affiliate account once the user pays their tuition in full.

If the user upgrades or downgrades their Tuition your income for that user will also reflect that change.

We will pay the affiliate fee until this user cancels their paid subscription.

Affiliate fees will be paid only on persons who are registered, tracked and reported in the affiliate system. The visitor is not tracked by cookies nor links; the Registrant must identify the Affiliate on www.mitntraining.com as their referral source.

Affiliate fees are paid via Check or Electronic Payment every quarter based on the students payments.

Affiliate fees are calculated based on the USD prices and will be paid in USD.
